3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The Bristol Permanent Supportive Housing Program, developed and operated by People Incorporated of Virginia, provides safe, decent housing and critical supportive services for 12 chronically homeless men in Bristol, VA. One hundred percent of the program participants are chronically homeless with disabling characteristics, which vary, but include physical or developmental disabilities, mental illness, or substance abuse. Every person previously lived on the streets, in emergency shelters, or in places not meant for human habitation. To date, the Bristol PSH program has housed 43 chronically homeless individuals.

The part-time, on-site case manager connects program participants with medical and mental health care, social services, and substance abuse counseling to ensure that their basic needs are met. The case manager teaches life skills (e.g. housekeeping, nutrition counseling) and financial literacy education (e.g. creating and managing checking or savings accounts), and helps individuals secure and sustain employment. People Incorporated's Adult Workforce Development Program also makes job training available at no cost. People Incorporated also offers other services to the residents at the facility, such as, homeownership counseling and classes, Individual Development Accounts (matched savings for homeownership, business, or school expenses), and free income tax preparation.

The case manager regularly works with local organizations to determine the extent and availability of services in the community so that program participants receive appropriate assistance to help them move toward an independent lifestyle and achieve a level of self-sufficiency that can be maintained in light of their disabilities. Supportive services are made available on site or transportation is provided, either through public transit or by the case manager, to and from the site of the services. The case manager helps individuals identify and apply for appropriate health and social service program benefits, including: SSI, Medicaid, and SNAP through the Department of Social Services; Workforce Investment Act programs operated by People Incorporated; and the Veterans Affairs programs through the Johnson City Medical Center. Participants are made aware of supportive services and public benefits through group and weekly one-on-one meetings.

Individuals access permanent supportive housing when they become a tenant at the Bristol PSH facility based on the housing first model. With support from the dedicated case manager and program participants' own efforts, some clients are able to move to permanent independent housing. The case manager plays an active role by helping individuals develop independent living goals, and strategies to move toward achieving those goals.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The Bristol Permanent Supportive Housing Program, developed and operated by People Incorporated of Virginia, provides safe, decent housing and critical supportive services for 12 chronically homeless men in Bristol, VA. One hundred percent of the program participants are chronically homeless with disabling characteristics, which vary, but include physical or developmental disabilities, mental illness, or substance abuse. Every person previously lived on the streets, in emergency shelters, or in places not meant for human habitation. To date, the Bristol PSH program has housed 43 chronically homeless individuals.

The part-time, on-site case manager connects program participants with medical and mental health care, social services, and substance abuse counseling to ensure that their basic needs are met. The case manager teaches life skills (e.g. housekeeping, nutrition counseling) and financial literacy education (e.g. creating and managing checking or savings accounts), and helps individuals secure and sustain employment. People Incorporated's Adult Workforce Development Program also makes job training available at no cost. People Incorporated also offers other services to the residents at the facility, such as, homeownership counseling and classes, Individual Development Accounts (matched savings for homeownership, business, or school expenses), and free income tax preparation.

The case manager regularly works with local organizations to determine the extent and availability of services in the community so that program participants receive appropriate assistance to help them move toward an independent lifestyle and achieve a level of self-sufficiency that can be maintained in light of their disabilities. Supportive services are made available on site or transportation is provided, either through public transit or by the case manager, to and from the site of the services. The case manager helps individuals identify and apply for appropriate health and social service program benefits, including: SSI, Medicaid, and SNAP through the Department of Social Services; Workforce Investment Act programs operated by People Incorporated; and the Veterans Affairs programs through the Johnson City Medical Center. Participants are made aware of supportive services and public benefits through group and weekly one-on-one meetings.

Individuals access permanent supportive housing when they become a tenant at the Bristol PSH facility based on the housing first model. With support from the dedicated case manager and program participants' own efforts, some clients are able to move to permanent independent housing. The case manager plays an active role by helping individuals develop independent living goals, and strategies to move toward achieving those goals.

People Incorporated has been managing federal grants for over 50 years effectively utilizing funds for their intended purpose to meet programmatic goals. The proposed program is already in place. The new funding will allow for an expansion of services to improve program performance. Therefore, there is no necessary start-up period. The program will commence immediately upon signing of a contract. The funding requested is sufficient to meet the identified goals.

2. Describe the experience of the applicant and potential subrecipients (if any) in leveraging other Federal, State, local, and private sector funds.

The Cumberland Plateau Local Planning Group includes People Incorporated, Clinch Valley Community Action and the City of Bristol. Through these organizations, the LPG has been able to not only meet the required match for all of its homeless services programs (25% for both VHSP and HUD CoC) each year, but has often been able to surpass the minimum required match. Resources come from local nonprofits, volunteer hours and other in-kind, local government sources, and state and federal government funding.

People Incorporated, as a community action agency, has operated since 1964 with a variety of funding sources from government and private sources. The agency administers over 60 funding sources each year with the assistance of Sage Accounting Software, which is intended for nonprofits managing multiple revenue streams. People Incorporated adheres to all accounting standards and has had no findings in its most recent audit.

Homeless services are part of the agency's Department of Housing Services. People Incorporated rehabilitated the former nurses' quarters at King's Mountain Hospital into 12 units of permanent supportive housing. All of the program participants are chronically homeless men with disabling characteristics, which include physical or developmental disabilities, mental illness, and substance abuse.

Through encouragement and industriousness from both the Case Manager and the individual, residents are encouraged to improve their economic condition and move into permanent housing. The case manager actively helps individuals develop independent living goals by connecting them to public support, and teaching the necessary life skills to prepare them to fulfill their maximum potential and achieve their goals. This request for funding is designed to expand supportive services in order to increase the number of clients leaving the property to move on to permanent housing and decrease the amount of time they remaining at the facility.

2. Permanent Supportive Housing provides the ultimate form of Housing First and supportive services to prepare clients to obtain and maintain housing long-term after leaving the program. At King's Mountain this is done in coordination with the entirety of the Cumberland Plateau Local Planning Group services and includes intensive case management as well as strong relationships with local landlords. People Incorporated excels at helping clients access mainstream resources to meet all of their needs and help clients overcome the barriers to housing that initially led them to homelessness. This is facilitated by the agency's internal client management database that evaluates a client's eligibility for services and tracks referrals for programs both internally and externally. The expansion of supportive services under this new request for funding will provide additional resources for client to help them become stable and ready to move to permanent housing.

3. What specific plan does this project have to specifically coordinate and integrate with other mainstream health, social services, and employment programs for which program participants may be eligible?

The initial intake session allows case managers to evaluate barriers using the standardized VI-SPDAT assessment and connect participants with targeted and coordinated homeless services, homeless prevention programming, and mainstream resources within the local planning group jurisdictions through a resource guide, updated yearly, in order to assist the participants with their housing and other immediate needs as quickly as possible.

In addition, People Inc. provides a presumptive eligibility check for services for all clients, regardless of which of the agency's 28 programs the client initially seeks assistance from. This is done through the intake assessment process. The agency database, used in conjunction with HMIS, helps identify other programs to address the clients' needs and screen them for basic eligibility requirements. Client referrals are monitored in the database as well for both internal and external program referrals.

C. FIXED RATES:

If a fixed rate is in this Agreement, it is based on an estimate of the costs for the period covered by the rate. When the actual costs for this period are determined, an adjustment will be made to a rate of a future year(s) to compensate for the difference between the costs used to establish the fixed rate and actual costs.

D. USE BY OTHER FEDERAL AGENCIES:

The rates in this Agreement were approved in accordance with the authority in Title 2 of the Code of Federal Regulations, Part 200 (2 CFR 200), and should be applied to grants, contracts and other agreements covered by 2 CFR 200, subject to any limitations in A above. The organization may provide copies of the Agreement to other Federal Agencies to give them early notification of the Agreement.

E. OTHER:

If any Federal contract, grant or other agreement is reimbursing indirect costs by a means other than the approved rate(s) in this Agreement, the organization should (1) credit such costs to the affected programs, and (2) apply the approved rate(s) to the appropriate base to identify the proper amount of indirect costs allocable to these programs.
