3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

This renewal request will allow for the continuation of services through the Foothills Network Local Planning Group. People Inc. took over administration of the program three years ago from Fauquier County. Community Touch and Culpeper Housing and Shelter Services are the subrecipients for the program providing direct services in the area. They have decades of experience providing services to the homeless in the region and operate emergency shelters as well as homeless prevention services.

Clients are referred to the program from the Central Entry system. Most often, in order to prevent a client from continuing to live in a place not meant for human habitation, clients are referred from Central Entry to one of the local emergency shelters while they are enrolled in the Rapid Re-housing program and search for housing. Therefore, the majority of people who come to the program enter from a shelter rather than a place not meant for human habitation.

Clients entering the Rapid Re-housing program receive a complete assessment using the VI-SPADT. In addition to rent assistance, clients receive, as necessary, intensive case management clients, assistance identifying and securing housing, and ongoing supportive services. The program is well integrated into the full array of housing services in the community. The Community Services Board, which is the administrator of the Housing Choice Voucher program, is part of the Foothills Housing Network and works with all of the programs to coordinate services and assist clients in moving on from the program. FHN's Rapid Re-housing program has been able to provide short-term housing for some CSB clients waiting on Permanent Supportive Housing assistance until they can be enrolled in the CSB program. FHN and CSB staff worked jointly with landlords so participants aren't required to move when they switch to the new funding source.

A. LIMITATIONS:
