2026 Balance of State Continuum of Care Funding Appeals Process

- Applicants will receive a summary of the priority ranking on August 11th, 2026.
- Applicants that wish to appeal the ranking committee's decision must notify the Department of Housing and Community Development's Homeless and Special Needs Program Manager (Darl Wilburn, darl.wilburn@dhcd.virginia.gov) in writing via email no later than close of business August 14th, 2026 with the following information
 - Agency name and contact information
 - Project name
 - Specific reason for appeal
- **Applicant should note a clear explanation of the grievance with the grant application or decision-making process in their appeal.**



- The Ranking Committee will review all appeals and make final decisions on August 17th, 2026 via email vote.
- Applicants will be notified in writing of the appeal outcome not later than August 17th, 2026
