Comments: Ms. Davis summarizes and brings in some last-minute amendments from the energy Subworkgroup to include raising the number of air changes from 3 to 5 and adding language to allow testing to be conducted by a <u>Virginia licensed HVAC contractor</u>, a <u>Virginia licensed Home Inspector</u>, a <u>Virginia licensed design professional</u>, a certified BPI Envelope Professional, or a certified HERS rater, or a certified Duct and Envelope Tightness rater as long as they are trained on the testing equipment. Mr. Lacey summarizes some changes and Mr. Clark speaks in support of this item.

Ms. Eggerton speaks in favor of the need to insulate to prevent water accumulation in ducts. Several others support that they have witnessed damage due to water accumulation in uninsulated ducts. Mr. Grace requested that this proposal be withdrawn after doing additional research on the proposal at the national level.

Mr. Ainsley spoke to nuisance tripping that occurs as a worry for requiring these in single-family homes. Mr. Haywood spoke to improvements in AFCI technology that have greatly reduced costs and risks associated with AFCI. Mr. Clark requests additional data for direct evidence to the life-saving factor of these devices. Mr. Iverson speaks in favor of instituting this protection in homes doesn't have direct life-saving aspects.

Comments: Mr. Harrington speaks to what prompted this proposal. Mr. Erler summarized his proposal. Mr. Kines and several others spoke in opposition of this proposal and recommended taking this through the national process and suggested that the 2020 NEC adequately addresses the issue and a possible solution would be to bring in the 2020 NEC requirements. Mr. Witt recommended carrying this over and bring in subject matter experts to address this issue. Mr. Erler suggested that the national recommendations in the 2020 NEC would not resolve the issue in Smith Mountain Lake. Mr. Kines defended the NFPA process. Delegate Byron asked about

the order of the process and supported the proposal. Consensus from proponents to carryover in order to convene a subworkgroup in the final phase to study the issue.

TM505.6 Other than Group R (hoods for domestic cooking appliances) **Proponents:** Kenney Payne, AIA-VA (<u>kpayne@moseleyarchitects.com</u>)

Comments: Proponent summarizes that current code language mandates a domestic hood. He is attempting to clarify that it is optional.

TM510.7.1.1 Shaft penetrations that penetrate fire-resistance-rated shafts

Comments: Proponent summarizes that the intent of this proposal is to clarify that firestop systems cannot take the place of required fire dampers.

TP403.1 Increase number of required water closets in passenger terminals and transportation facilities

Proponents: Cornelia Weiss (koislmeier@yahoo.com)

Comments: Ms. Weiss summarized her proposal. Mr. Payne spoke to the requirements imposed by the language and suggested edits, including consideration of increasing the required number of lavatories as well. A comment was made that this change could affect other transportation facilities and should be vetted at the national level. Mr. Moldovan suggested some changes as well. Some commenters offered to work with the proponent to clean up the proposal to address some of the concerns that had been raised. Mr. Witt recommended carryover to continue edits.

TP410.4 Substitution (drinking fountains and water dispensers) **Proponents:** Richard Grace (<u>richard.grace@fairfaxcounty.gov</u>)

Comments: Proponent summarized the proposal and the changes made since last time it was discussed. Mr. Clements suggested a change to the language to further clarify the requirement for two fountains, one high and one low. Ms. Eggerton suggested removing "notwithstanding" and that it may be beneficial to carry over this proposal to find language that isn't confusing. Mr. Grace suggests an edit from the 2021 IPC "Where more than two drinking fountains are required... water dispensers shall be permitted to be substituted for not more than half...." The group agreed to use the 2021 IPC language.

Mr. Pharr spoke to the broadband issues in the commonwealth and argued for having online submittals as an option. Ms. Eggerton supported the proposal as an option, even the preferred option. Mr. Lederman (VDEQ) spoke to this being an issue for them as well.

Ms. Cook asked if this was a problem that has occurred where building offices were required to conduct final inspections on unpowered structures. Mr. Clements spoke in opposition. A comment was made that the existing provision in the USBC was added to allow a building official to require power when it was appropriate and mandating it for all final inspections would require it even when it is not feasible or appropriate. Mr. Redifer opposed this on the grounds that building offices should have the option to make the decision.

Comments: Rests on reason statement. Mr. Pharr defends proposal that this does not supersede or interfere with the Landlord Tenant Act. Mr. Payne spoke to TRB cases about this topic. Mr. Clark spoke to General Assembly implications of this proposal. Theresa asked how they were supposed to get ahold of the owner of a property to determine if it's a failure of the owner or the tenant. Mr. Clements states that the language of this change gives the building official the ability to request information pursuant to a deficiency. Ms. Hale asked about the scope of this change and Mr. Witt clarified for her. Mr. Pharr suggested that he could remove reference to the Residential Landlord Tenant Act and preserve the second part in 103.2.3.1. Ms. Davis summarized to this point. Mr. Witt requested to make 103.2.3 to a Note and reference the Code of Virginia.

"Note: Where an owner states that a tenant is responsible for performing any of the owner's duties under this code, the code official may request information needed to verify the owner's statement, as allowed by Section 55-1-1209A.5 of the Code of Virginia."

B108.1 Emergency supplemental hardware per SB1755

Proponents: DHCD Staff on behalf of the following stakeholders represented at the School Safety Subworkgroup: Virginia Building & Code Officials Association; Virginia Department of Education; Augusta County Public Schools; American Institute of Architects (AIA) Virginia; Virginia Tech

Comments: Ms. Davis recaps both of the two proposals brought forth from Senate Bill 1755 and the review of the use of barricade devices and locks during active shooter and emergency situaltions. She explained that the two proposals were the same except this proposal put the clarifying language in the body of the code and the alternate proposal puts the language in an appendix that would make it optional for jurisdictions to choose to use them. The concern with

the appendix is that one school district would be able to use an approved device as outlined in the appendix and the school in the next county would receive a notice of violation for using the exact same device. She opened the floor for other committee members to discuss relevant proposals. Ms. Frye stated that she has concerns that the proposal as written does not prohibit barricade devices from being installed on doors with required panic hardware. Mr. Witt stated that there had been four meetings with over twenty hours of discussion. He saw no benefit in rehashing the arguments at this meeting and suggested that both simply be moved forward as non consensus.

BO108.1 Appendix O option per SB1755

Proponents: Linda Hale on behalf of VFPA and Steven Sites, Acting State Fire Marshal **Comments:** See above. Ms. Davis asked Ms. Hale if the language in the appendix was identical to the other proposal. Ms. Hale stated that it was identical as she simply used the copy and paste to submit her proposal and that it was her intent that it be exactly the same. Mr. Milliken recommends moving the changes in VSFPC section 1010.1.9.3 to 1031. Mr. Payne indicated VA AIA would support the appendix option as well.

B310.1 Residential Group R (Residential use subworkgroup)

Comments: Ms. Davis summarized how multiple residential uses were consolidated to this proposal and how it may have caused unintended consequences with the new definition of R-1 as it might be interpreted to include vacation rentals Mr. Brown summarized some of the good work accomplished by this language. Mr. Willham asked a question about transient occupancy and comparing this to IRC language. Mr. Milliken suggests that any change to hospice be reflected in the VSFPC for drills. Mr. Brown indicated this was already done. Ms. Cook asked about transient language in R-uses impacting multi-unit apartments being utilized by AirBNB. Mr. Clements spoke to the work accomplished by the group and that "primarily transient" was the best defining term for limiting the scope of these use groups. Mr. Gerber asked how occupant load definition could be enforced. Mr. Willham recommends adding "more than one dwelling unit" to "ten or more occupants" to further clarify.

Mr. Moldovan asked how "owner occupied" would impact the building official and he does not want to bring forth a proposal with unenforceable language.
