#### **2021 Highlights**

#### Deputy Director Cindy Davis Selected President of the International Code Council (ICC) Board of Directors



In September of 2021, the ICC held their annual conference in Pittsburgh, where Cindy Davis, deputy director of Virginia's Building and Fire Regulations, was elected to serve as the president. The ICC board is responsible for the International Code Council's strategic direction, including codes and standards development, while also acting as the voice of the association's membership.

#### **Awards and Accolades**

- At the Viridiant Building Sustainability Awards on Sept. 29, DHCD was awarded the Building Sustainability Award for Project, Program or Initiative in recognition of DHCD's code development process, grant work and collaboration with Viridiant and Southeast Energy Efficiency Alliance to improve energy code implementation throughout the state.
- The Insurance Institute for Business and Home Safety (IBHS) Rating the States 2021 report, which evaluates the 18 states along the Atlantic and Gulf coasts based on building code adoption, enforcement and contractor licensing, ranked Virginia second, falling only one point behind Florida.
   Virginia was described as having "one of the strongest code enforcement programs among the group."
- Virginia ranked first in the South on the American Council for an Energy-Efficient Economy (ACEEE) State Efficiency Scorecard.
- FEMA's Building Resilient Infrastructure and Communities (BRIC) grant
  program selected DHCD to receive funding to provide ICC's "When Disaster
  Strikes" training to code enforcement personnel throughout the state as a
  first step towards developing a statewide disaster response network.
- Deputy Director Cindy Davis received the Jack A. Proctor Meritorious Service Award at the VBCOA annual conference.

#### **Supporting Jurisdictions**

Through VBCA, BFR provided ICC memberships for 162 jurisdictions, enforcing the Uniform Statewide Building Code and continuing the practice of providing a full set of 2018 Virginia codes to all Virginia building departments.

### State Technical Review Board (STRB)

The State Building Code Technical Review Board (STRB) consists of 14 citizens, appointed by the governor to ensure Virginia's building code is administered fairly and is well-understood by the residents of Virginia. The board's primary purpose is to hear appeals from enforcement actions under the Virginia Uniform Statewide Building Code, the Virginia Statewide Fire Prevention Code, the Virginia Industrialized Building Safety Regulations, Virginia Amusement Device Regulations and the Virginia Certification Standards.

The board also provides interpretations to the provisions of the USBC and SFPC and makes recommendations to the Virginia Board of Housing and Community Development for future modifications, amendments or repeals of such provisions.

### Manufactured Housing (MH) 2021 Snapshot

Manufactured housing is an important source of affordable housing for Virginians. Manufactured homes, sometimes referred to as HUD code homes, are built in a factory on a permanent chassis with transportable sections, and are used as single family dwellings. They may be sited with or without a permanent foundation.

DHCD regulates Virginia's manufactured housing industry through the Virginia Manufactured Home Safety Regulations (MHSR) and the Virginia Manufactured Housing Licensing and Transaction Recovery Fund Regulations (MHLTRFR). Through these regulations, DHCD licenses dealers, manufacturers and salespersons and provides administrative support to the governor appointed Manufactured Housing Board to hear complaints against licensees.

The design, construction, in-plant inspections and certifications of manufactured homes are done under a federal program administered by the U.S. Department of Housing and Urban Development (HUD). DHCD, as the state administrative agency (SAA) for HUD, handles all consumer complaints for manufactured homes that are manufactured, sold or installed in Virginia. As the SAA, DHCD administers HUD approved installation and dispute resolution programs for manufactured housing in Virginia.

### Industrialized Buildings (IB) 2021 Snapshot

Industrialized Building Safety Regulations (IBSR) help uniformly regulate industrial buildings (IB), often referred to as modular buildings. IBSR provides for the administration and enforcement of consistent, mandated statewide standards. DHCD is the agency responsible for IBs, and accredits third-party compliance assurance agencies (CAAs) to review designs, inspect construction and certify the buildings through the application of the Virginia Registration Seal. DHCD oversees the performance of each CAA.

The finalized language in the 2018 regulatory process will add additional guidance for shipping containers and panelized construction.

### Virginia Manufactured Housing Board (MHB)

#### 2021 Board Overview


The Virginia Manufactured Housing Board (MHB) is composed of nine members appointed by the governor, representing different groups who are designated to enable legislation. The MHB adopts and, with the assistance of DHCD staff, executes enforcement of the Virginia Manufactured Home Safety Regulation (MHSR) and the Manufactured Housing Licensing and Transaction Recovery Fund Regulations (MHLTRFR).

The board is responsible for licensing manufactured home dealers, brokers, manufacturers and salespersons working for those companies. The board is also authorized to receive consumer complaints regarding manufactured homes and make case decisions as necessary to resolve complaints.

The Manufactured Housing Board (MHB) met once during 2021 to receive updates and to elect Kris Bridges as chair and Travis Luter as secretary.

#### **Code Development**

Building and Fire Regulations staff finalized and published the 2018 Virginia building and fire regulations and partnered with ICC to publish the custom Virginia code books. The 2018 Virginia codes became effective in the commonwealth on July 1, 2021. Building and Fire Regulations staff developed 2018 Code Change Training for all Virginia code enforcement personnel and offered multiple live virtual training sessions as well as self-paced online training for each module.

The 2021 code update cycle kicked off in October, 2021 with the publication of the Notices of Intended Regulatory Action (NOIRA). This action alerts the public that the Board of Housing and Community Development (BHCD) intends to consider amending the regulations outlined in the code. Three separate study groups began meeting in December to discuss In-Building Emergency Communications Systems, Townhouse Sprinklers and Active Shooter Barricade Devices in Public Buildings.




# State Building Codes Field Office Southwest Virginia Spotlight 2021

It has always been a goal of the Division of Building and Fire Regulation to serve and provide support to building departments and other stakeholders throughout the commonwealth. Several years ago, Deputy Director Cindy Davis asked a code and regulation specialist to attend VBCOA meetings in Southwest Virginia), provide updates on BFR activities, give informal code opinions, bring training to the regions and provide other general support. These efforts were well received, and in December of 2019, DHCD opened an office in Wytheville and hired a building official from SWVA, who continues to provide the support needed in the region.

The Wytheville Office recently expanded to two staff members; Brian Hilderbrand, construction regulation administrator and Chad Lambert, Southwest Virginia code and regulation specialist. Their responsibilities also include the administration of DHCD's Manufactured Housing and Industrialized Building programs. Any questions or issues related to these programs can be directed to them or Thomas King, code and regulation specialist in the Richmond area. They are continuing to provide support and develop relationships throughout Southwest Virginia.

- The new format includes online self-paced prerequisites.
- Core will continue to be refined for full launch and release in 2022.

#### Successful launch of Code Change Training -Live Virtual and Self-Paced Online offerings

- Partnered with subject-matter experts across the state to develop a comprehensive training curriculum focused on the 700+ changes impacting the Virginia codes this cycle.
