- Applicants will receive a summary of the priority ranking on Oct. 6th, 2021.
- Applicants that wish to appeal the ranking committee's decision must notify the
 Department of Housing and Community Development's CoC Program Coordinator (Ara
 Mendoza, ara.mendoza@dhcd.virginia.gov)in writing via email no later than close of
 business Oct. 12th, 2021 with the following information
 - Agency name and contact information
 - Project name
 - Specific reason for appeal
- Applicant should note a clear explanation of the grievance with the grant application or decision-making process in their appeal.
- The Ranking Committee will review all appeals and make final decisions on Oct. 15th,
 2021 via email vote.
- Applicants will be notified in writing of the appeal outcome not later than Oct. 18th, 2021.
