

Unobligated Fund Balance Recapture Method



- <u>Item 3-1.01 #3c</u> directs the State Comptroller to transfer \$27,515,896 from the Virginia Growth and Opportunity Fund to the General Fund.
- This figure is the approximate sum of all unobligated funds from FY19, FY20, FY21, which includes the Economic Recovery and Resilience initiative.
- While the budget is not descriptive of which funds will be subject to recapture, staff has prepared two recapture methods for consideration. Neither of the proposed methods would impact FY22 unobligated fund balances and would not jeopardize the funding Per Capita applications under consideration.
- The Board may wish to consider alternatives to these recommendations.





Option 1:

Rescind \$18.6M in unobligated Per Capita funds previously allocated by the State Board as well as balance of FY21 unobligated Statewide Competitive funds, totaling \$23.6M.

Move the submitted ERR applications forward.

Rescind \$1.4M in FY22 Statewide Competitive Funds

Return the ERR initiative balance of \$3.9M, leaving 5 projects unfunded.

Application Process



- Applications are submitted to Regional Councils
- Approved applications are advanced to DHCD
- Technical reviewed by DHCD staff
- Workgroup review and pitch calls
- Staff prepares recommendations for Board
- Presented for Board consideration
 - Approve
 - Defer
 - Deny
- Approved projects go to contract



Region 5: Maritime Entry-to-**Employment Training (MEET)**

Participating Localities:

City of Chesapeake Public Schools, City of Hampton Public School, City of Newport News Public Schools City of Norfolk Public Schools, Suffolk Public Schools

Investment Strategy: Workforce Development

Goal: To build an online training delivery platform in three maritime trades courses in sheet metal fabrication, pipefitting, welding, and enry-level Fiber Optic Technician training through a partnership with New College Institute.

Outcomes:

- Create at least two online maritime courses and fiber optic technician courses
- Train 390 total students within 3 years
- Train 706 total students within 5 years

Region 7: Nano-IMAGINE

Participating Localities:

Prince William County, Northern Virginia Economic Development Alliance on behalf of its member localities

Investment Strategy: Workforce Development

Goal: To catalyze growth of Virginia's nanotech sector by providing hands-on workforce training and supporting the launch and growth of high-tech nanotechnology startups.

Outcomes:

- 185 new jobs created in nano-tech in year 3
- 233 new jobs created in nano-tech in year 5
- 3 new nano-tech startups created
- 26 new technical graduate and undergraduate classes with hands-on room training







Region 8: Accelerating Advanced Manufacturing Workforce

Participating Localities

Frederick County Economic Development Authority, Shenandoah County Economic Development Authority, Winchester Economic Development Authority

Investment Strategy: Workforce Development


Goal: To build a strong workforce pipeline for Region 8 manufacturers, meeting needs of a diverse cluster including materials, parts, machinery, food, and pharmaceutical producers through implementation industry approved credentialing and degree opportunities.

Outcomes:

- 336 students trained
- 300 credentials awarded
- · 288 jobs filled







Region 9: Talent Supply Connector

Participating Localities:

Culpeper County, Greene County Public Schools, Louisa County Public Schools, Nelson County, Madison County

Investment Strategy: Workforce Development

Goal: Execute workforce strategies identified in the Labor Sector Strategies Report (LSSR), and develop sector-driven credentialing, apprenticeship, and/or

internship programs that build talent pathways to serve priority industries.

Outcomes:

- 180 new internships
- 90 new jobs
- 20 Light Manufacturer businesses served
- 20 Food & Beverage Manufacturer businesses served







Region 9: Tech Talent Retention

Participating Localities:

City of Charlottesville, Counties of Albemarle, Madison, Nelson, Culpeper,

and Louisa

Investment Strategy: Workforce Development

Goal: To retain UVA college graduates in the Central Virginia region and to provide a talent pipeline for higher paying jobs in technology fields in Region 9 aligned targeted sectors.

- 55 new jobs created
- 100 businesses served





Region 9: Technology Academies for Fauquier and Rappahannock Counties



VIRGINIA INITIATIVE FOR GROWTH & OPPORTUNITY N EACH REGION

Participating Localities: Faquier County, Rappahanock Public Schools

Investment Strategy: Workforce Development

Goal: To develop technology academies for students that will offer college level courses in robotics and drones.

- 69 jobs filled
- 90 students trained
- 6 internships created
- 2 new programs with 4 industry-relevant certificates/credentials
- 90 credentials awarded
- 80 students enrolled in dual enrollment programs





Region 5: Hampton Roads Economic Development Sites Readiness II

Participating Localities:

- Southampton County, City of Chesapeake
- Investment Strategy: Site Development

Goal: To complete due diligence work recommended by earlier studies for two sites in Region 5, helping to accelerate their development to Tier 4, and to complete a site characterization study for a third site.

- 90 acre site elevated from Tier 2 to Tier 4
- 80 acre site elevated from Tier 2 to Tier 4
- 80 acres site characterized for development
- Up to 400 jobs created





Region 2: Workforce and Entrepreneurship Initiatives in a Regional Makerspace

Participating Localities: City of Lynchburg, Counties of Bedford and

Campbell

Investment Strategy: Workforce Development/Start-up Ecosystem **Goal:** To expand programming and add new equipment at Vector Space to support entrepreneurship and workforce development for the manufacturing sector.

- 37 jobs filled over three years (previously 22)
- 8 businesses launched (previously 4)
- 5 existing businesses served





Region 7: Accelerate 2023/2024

Participating Localities: Arlington Couny, Fairfax County Investment Strategy: Start-up Ecosystem

Goal: To strengthen and advance Northern VA as a world-renowned center of excellence for innovative emerging technologies, benefitting the regional community and promoting economic growth by drawing capital from around the country to a showcase of the top tech companies in Virginia. **Outcomes:**

- 100 new jobs created
- \$50 million total capital raised
- 100 entrepreneurs engaged





Region 9: Carver Food Business Incubator

VIRGINIA INITIATIVE FOR GROWTH & OPPORTUNITY IN EACH REGION

Participating Localities: Town of Culpepper, Counties of Fauquier, Orange, and

Rappahannock

Investment Strategy: Start-up Ecosystem

Goal: To support and scale Region 9 food and beverage manufacturing companies, support development of new manufacturing products to be sold across state lines, and convert the former George Washington Carver Regional High School into a thriving and sustainable agricultural education, production, research, and training hub.

- 173 new jobs created
- 68 businesses served
- 67 new products released to market
- 15% increase in sales for businesses served

Region 1: UWSVA- Employer-Sponsored Childcare Benefit, 2022

Participating Localities: Counties of Buchanan, Tazwell, and Smyth Investment Strategy: Workforce Development

Goal: To fill manufacturing jobs by increasing the labor force participation rate through the development of a pilot program to expand the capacity of the child care industry and address cost barriers through the development of an employer-sponsored benefit program.

- · 52 businesses participating on committee or engaged in project activities
- 4 businesses participating in the employer-sponsored childcare benefit program
- 76 jobs filled/retained
- · 25 organizations served by the Regional Shared Service Alliance





Region 6: Rappahannock and Germanna Community Colleges Patient Care Technician

Participating Localities: City of Fredericksburg, Counties of Essex, Spotsylvanie, Stafford and

Gloucester

- Investment Strategy: Workforce Development
- Goal: To develop and deliver a new, non-credit Patient Care Technician Program to

address critical healthcare shortages exacerbated by the pandemic.

Outcomes:

- Development of the Patient Care Technician program (non-credit)
- 120 students trained
- 110 students completers
- · 82 students credentialed
- 62 jobs filled







Region 8: NextGen Nurses

Participating Localities: Counties of Page, Shenandoah and Warren **Investment Strategy:** Workforce Development

Goal: Shenandoah University and Valley Health System will partner to develop and deliver a pilot that will increase the number of Nurse Preceptors, increase the number of clinical hours achieved in University Simulation Lab, and increase the number of newly trained nurse graduates to address critical healthcare shortages exacerbated by the pandemic,.

- Development of Nurse Preceptor curriculum
- Enhanced Simulation Lab capabilites at Shenandoah University
- 35 new preceptors trained
- 140 additional nurses trained
- 25% of clinical hours achieved by 460 Shenandoah University nursing students





Region 9: BEACON's Kitchen

Participating Localities: Alebemarle County, City of Charlottesville Investment Strategy: Start-up Ecosystem

Goal: To provide technical traning and certification course as well as an expanded commercial kitchen to stabelize existing Food and Beverage businesses still recovering from the economic impact of the COVID-19 pandemic and to grow Food and Beverage manufacturing activity in the region.

- 77 new jobs created
- · 28 new businesses created
- 30 new tradeable food products produced
- 40 businesses served

GO Virginia Talent Pathway Initiative

- **Budget Language:** Item 114 #1c (HB 29) outlines a new one-time \$2,500,000 allocation to the Growth and Opportunity Virginia Program for the GO Virginia Talent Pathways Planning.
- Planning Grants Goal: To identify and address business workforce needs in
- regional industry clusters.
- **Key Partner:** Virginia Economic Development Partnership Office of Education and Labor Market Alignment (OELMA)







- DHCD and VEDP to collaborate on program guidelines.
- DHCD and VEDP develop joint recommendations on submitted applications for consideration by the GOVA State Board.
- VEDP OELMA to provide analytical support to regional councils in developing the analysis.
- As a condition of the grant, regional councils shall provide quantitative and qualitative information on current and future needs of regional businesses within the targeted industry clusters to VEDP - OELMA.
- This planning grant program shall last no longer than a year from its start date, and represent a one-time appropriation of funds for this purpose.
- Any funds remaining at the end of the fiscal year shall not revert to the general fund and shall be carried forward into the next fiscal year by the department for the purposes described.
