Mr. Mays moved that the answer to the question of whether PEX-AL-PEX piping, listed under ICC-ES Product Certificate PMG-1588, and proposed for use as fuel gas piping within or under a building, at least equivalent in safety and suitability, to other pipe materials listed for such use in the Virginia Fuel Gas Code and the Virginia Residential Code to be "*No*". The motion was seconded by Mr. Zdinak and passed unanimously.

After further deliberation, Mr. Mays moved to reconsider the previously approved motion. The motion was seconded by Mr. Zdinak and passed unanimously.

After further deliberation, Mr. Mays moved to amend the previous motion to be that the answer to the question of whether PEX-AL-PEX piping, listed under ICC-ES Product Certificate PMG-1588, and proposed for use as fuel gas piping within or under a building, at least equivalent in safety and suitability, to other pipe materials listed for such use in the Virginia Fuel Gas Code and the Virginia Residential Code to be, "No, the VFGC and VRC require polyethylene plastic pipe and tubing used for fuel gas to conform to ASTM D2513 and aluminum-alloy pipe and tubing used for fuel gas to conform to either of these standards." The motion was seconded by Ms. Jackson and passed unanimously.
